Englewood NJ, March 23, 2021 – We regret to report that there have been a total of **73 cumulative deaths of Englewood residents** that have occurred. **There were 10 new positive cases reported since Monday, 3/22, with a total (cumulative) of 2,597 known positive COVID-19 cases of Englewood residents.** It is likely there are more positive cases that have yet to be identified.

Two of the six regions (Southwest, and Southeast) are at a MODERATE. The other four regions (Northwest, Northeast, Central West, and Central East) and the Statewide activity level is at HIGH.

*It is important that you continue to practice **social distancing**, wash your hands frequently, and wear a face covering/ mask to minimize the spread of the virus and to continue to **flatten the curve**. Social distancing means that you should limit social contact with others and, if you must interact with people, **maintain a distance of at least six feet**.*

The Englewood Health Department received 100 doses of the Moderna COVID-19 Vaccine on February 3rd. All 100 doses have been administered, and an order for additional vaccine was submitted on February 7th. We received 200 Moderna vaccines on February 23rd, and inoculation appointments began on February 25th.

We have a waiting list with over 2,500 people registered, and it is growing rapidly due to the high call and email volume since February 5th. **At this time, we are unable to accept additional telephone calls** to add names to our waiting list. You may request that your name be added to our waiting list by emailing vaccineinfo@englewoodnjhealth.org. These requests will be addressed upon receipt of additional vaccine and the servicing of those already on the list.

If you previously called or emailed to add your name to our vaccine waiting list and have since received the vaccine at another location, please email us (EHDVaccineInfo@gmail.com).

COVID-19 Symptoms:

CDC's current list of symptoms of the novel coronavirus (COVID-19) includes: fever or chills; cough; shortness of breath or difficulty breathing; fatigue; muscle or body aches; headache; new loss of taste or smell; sore throat; congestion or runny nose; nausea or vomiting; diarrhea. CDC will continue to update this list as we learn more about COVID-19.

Look for emergency warning signs for COVID-19. If someone is showing any of these signs, seek emergency medical care immediately:

- Trouble breathing
- Persistent pain or pressure in the chest
- New confusion
- Inability to wake or stay awake
- Pale, gray, or blue-colored skin, lips, or nail beds, depending on skin tone

If you believe that you may have been exposed or have symptoms, contact your medical provider before you go there.

How to Protect Yourself and Others – CDC currently recommends that everyone should:

- Clean your hands often
- Avoid close contact
- Cover coughs and sneezes
- Clean and disinfect frequently touched surfaces daily
- Cover your mouth and nose with a cloth face cover when around others

While the CDC still recommends a quarantine period of 14 days, new guidelines have been introduced that shorten the quarantine time period as a means to reduce the burden and increase willingness to adhere to public health recommendations. According to the new guidelines, quarantine can end after day 10 without testing and if no symptoms have been reported during daily monitoring, or after day 7 after receiving a negative test result (test must occur on day 5 of quarantine or later). CDC's modified definition of a close contact specifies 15 minutes or more of close contact (within 6 feet) of exposure to an infected person during a 24-hour period in which the infected person is infectious (cumulative exposure).

Today (3/22) the NJ Dept of Health will be releasing guidance to allow in-person visits for long-term care residents regardless of vaccination status where COVID activity is lowest. Visitation options for essential caregivers, compassionate care, and outdoor visits will continue to be available.

3/17/21 - The Governor announced that the public health emergency in New Jersey is being extended for another 30 days in order to continue ongoing COVID19 mitigation efforts while vaccinating residents as quickly and safely as possible.

As of Friday 3/19, at 6:00 AM: **Indoor gathering** limit increases to 25 people; **Outdoor gathering** limit increases to 50 people; **Indoor capacity limits** for restaurants, gyms & health clubs, recreational facilities and arcades, and personal care businesses increases to 50% capacity.

Also effective 3/19, re. **Interstate Youth Sports Update**: Prohibition on outdoor interstate youth sports competitions will expire Friday; Prohibition on indoor interstate sports competitions will remain in effect; Health and safety protocols must be adhered to

New Jersey strongly discourages all non-essential interstate travel at this time. Travelers and residents returning from any U.S. state or territory beyond the immediate region (New York, Connecticut, Pennsylvania, and Delaware) should self-quarantine at their home, hotel, or other temporary lodging for 14 days. This includes travel by train, bus, car, plane and any other method of transportation. The self-quarantine is voluntary, but **compliance is expected**. New Jersey has Extended Open Enrollment to **May 15** for its Health Insurance Marketplace – Those whose annual income is up to 400% of the Federal Poverty Level (\$51,040 for an individual and \$104,800 for a family of four) qualify for state subsidies when buying health insurance through the state's marketplace. Subsidies are about \$484 per month.

City of Englewood Procedures/Policies:

The City's COVID Committee, in an abundance of caution, has decided that sponsorship of public events will continue to be withheld for at least the first three months of 2021. Additional information will be provided as it is available.

Tennis and Basketball courts re-opened as of July 6th 2020. Residents are required to adhere to SOCIAL DISTANCING in the City Parks when possible. Additionally, the WEARING OF FACE COVERINGS is strongly encouraged when practical, as well as frequent washing of hands and/or the use of hand sanitizer. The following areas of City parks remain closed: Playgrounds, Bathrooms, Picnic Areas, Pavilions, Water Fountains, Exercise Stations and Equipment, Athletic Fields (soccer, baseball, etc.). Parking lots will be limited to 50% capacity.
