

MESSAGE FROM THE DIRECTOR

In the spring of 2018, the City of Englewood recorded two confirmed cases of measles for the first time in approximately 17 years. Despite epidemics raging in other areas, the low infection rate of measles in our city is an indication that our public health system is working properly on several platforms. We are able to control the spread of highly contagious diseases because we have a comprehensive public health strategy established locally, statewide, and nationally.

Fighting measles starts with vaccination, and the Englewood Health Department is the front line of defense by offering free and/or low cost vaccines to our population during our bi-monthly Child Health Clinics. Our clinics are well attended and cost effective. The Department also conducts yearly audits at every daycare center and school to ensure compliance with all vaccine preventable diseases. These measures are the foundation for measles eradication in our city.

One of the primary functions of the local health department is to resolve epidemics and stop disease outbreaks. Englewood Health Department limited the spread of measles in 2018 by finding the threats, responding rapidly, and preventing new infections. We worked with the NJ Department of Health, local business partners, and healthcare providers to limit its spread. Staff established a measles vaccine campaign in the area of the two confirmed cases and provided support for individuals who were affected.

As a result of our efforts to contain this air-borne disease, the Englewood Health Department was invited to speak at the NJ Department of Health's Communicable Disease Forum. This gave us an opportunity to inform other public health officials about our ability to stop the spread of measles in our city so effectively.

I am very proud of our Health Department and the important role that we play to improve public health.

VITAL STATISTICS & LICENSING

In 2018, there was approx a 23% decrease in records filed, but the number of certified copies issued remained the same as 2017 – just over 14,000.

The number of dog and cat licenses issued (852 total) increased approximately 4%. Retail licenses have remained consistent, with 300 for food establishments, 10 public pools, and 6 general licenses. In addition, 68 temporary food licenses were issued for special events.

All Vital Statistics staff maintain certification as a Certified Municipal Registrar and participate in State sponsored trainings for continuing education credits. Staff is permitted to attend in-person trainings and participate in webinars on a rotating basis to ensure coverage of the office. Some in-person trainings included: Electronic Death Registration System presentation from a local funeral director; presentation on Ethics from a former Bergen County Prosecutor; presentation by the NJ Paternity Opportunity Program; National Notary Association presentation; and updates on vital statistics issues directly from the State Registrar's office.


The staff is the Customer Service team for the department and typically responds and routes over 30,000 telephone calls annually, which includes but is not limited to vital records orders world-wide, pet and retail licensing requirements, inquiries about health education events, and resident complaints.

ENVIRONMENTAL HEALTH

Under the direction of the Health Officer, the Environmental Health team consists of a Public Health Investigator and two Registered Environmental Health Specialists (REHS) and is the first line of defense in public health for Englewood. The unit enforces State and Local laws to safeguard the public in areas including, but not limited to, the following:

- Retail food inspections/complaint investigations
- Food recalls
- Emergency Response to floods, fire or power outages
- Animal bite investigations and suspected rabies exposure
- Childhood lead poisoning/investigations
- Inspection of recreational water facilities
- Tobacco Age of Sale Enforcement
- Stagnant water/mosquito complaints
- Responding to various public health complaints & Health Ordinance violations

The two REHSs reduce the possibility of food borne illness through inspections and enforcement of Chapter 24 of the State Sanitary Code. In addition, they educate food establishment personnel by teaching food manager and food handler courses.

The Public Health Investigator is certified to handle matters regarding animal control issues, childhood lead poison investigations, and various nuisance complaints.

Environmental Health staff resolves various types of complaints and violations by educating the public, raising awareness regarding violations and, when necessary, taking court action to resolve public health issues.

Retail Food Program

In 2018, the Englewood Health Department was responsible for monitoring the food safety of 220 retail food establishments, 42 vending machines and 59 temporary event vendors for community events in the city.

The goal of the program is to assure safe food to the public through efforts such as increasing awareness about proper handling practices with food handlers, owners, managers, and the public; routine inspections with mandated corrections; and legal enforcement and/or closure when all other efforts fail. We view food safety as a partnership between retail food establishments and this department.

While we look at all aspects of the operation, our concentration is on the five major risk factors identified by the Centers for Disease Control and Prevention. The following are the aspects of food handling that directly cause foodborne illnesses:

1. Poor personal hygiene
2. Inadequate cooking temperatures
3. Improper Holding temperatures
4. Unclean food contact surfaces
5. Unsafe food sources.

The Food Establishment Surveillance Program, conducted by this department is based upon the rules and regulations set forth in Chapter 24 of the New Jersey State Sanitary Code (NJAC 8:24- et al) and Public Health Practice Standards. Other local and state codes can also be used as needed.

When an inspection is conducted at a retail food operation, a health inspection placard is issued.

- **Satisfactory** (white placard) meaning the establishment is in compliance with the State Sanitary Code.
- **Conditionally Satisfactory** (yellow placard) the establishment is in violation of one or more sections of the State Sanitary Code and a re-inspection is required.
- **Unsatisfactory** (red placard) the establishment is in violation with one or more gross unsanitary conditions of the State Sanitary Code and poses an imminent health hazard. This results in the establishment ceasing all operations until the violations are corrected and compliance achieved.

These placards must be publicly displayed in the front entrance facing the street for easy viewing by the public. All inspections are available to the public for viewing on the City's website. Additionally, in the case of establishments that are graded as "Conditionally Satisfactory" or "Unsatisfactory" a report is submitted to The Record for publication.

Food For Thought

A biannual newsletter, Food For Thought, is created by the Registered Environmental Health Specialists as an educational support tool serving Englewood's restaurants, school cafeterias, mobile vendors, markets, nursing homes and the hospital. In 2018, the newsletter highlighted cooking temperatures, food recalls, highly susceptible populations and when employees should wash their hands. The items compiled by the Environmental Unit serve to educate and remind food establishments of proper practices and precautions to be taken in their establishments. The newsletter is also available to the general public on the City's website.

Temporary Food License Inspections

A temporary retail food establishment is one that operates for a period of no more than 10 consecutive days in conjunction with a single event or celebration. Temporary events involve the sale and/or preparation of food in an indoor or outdoor setting. A food vendor must obtain a temporary event license with the Health Department. An REHS is then required to inspect the vendor the day of the event to ensure all regulations under the State Sanitary Code are followed and that proper

food handling techniques are being observed. During 2018, there were 59 temporary licenses issued for events, some of which included:

City Licenses & Miscellaneous Inspections

The Englewood Health Department conducts Certificate of Occupancy and Continued Certificate of Occupancy inspections at retail food establishments, beauty, barber, and nail salons. These inspections are conducted to ensure compliance with all city and state regulations as well as the State of NJ Board of Cosmetology. In addition, the REHS is responsible for plan reviews for new construction and renovations of existing structures. Floor plans are required when:

1. There is new construction of a retail food establishment;
2. There is conversion of an existing structure for use as a retail food establishment;
3. There is remodeling of a retail food establishment or a change of type of retail food establishment; or
4. The health authority determines that plans and specifications are necessary to ensure compliance with these rules.

These plan reviews cover businesses such as retail food establishments, beauty, barber, nail salons and public recreational bathing facilities.

Public Health Recalls

The Environmental unit is alerted by the U.S. Food & Drug Administration (USDA), Food & Drug Administration (FDA) and the NJLINCS Health Alert Network via email. These alerts advise the REHS when action is required. In 2018, there were 305 food recalls, none of which required immediate action from the Englewood Health Department. When action is required, the Registered Environmental Health Specialist will may need to go to retail food establishments to have owners remove a product from the shelves and inform their customers of the recalls.

Public Recreational Bathing Facilities

In 2018, The New Jersey Department of Health adopted an amended Public Recreational Bathing Facility Rule. Changes included the way inspections are performed, definitions to new terms, sampling procedures, water quality and the completion of the operational checklist. Englewood has nine seasonal pools and two year round pools. Seasonal pools are inspected once during the season; year round pools are inspected twice a year. During the course of each inspection a pool is checked for water quality/proper chemical levels, adequate safety equipment, properly certified lifeguards and that there are no hazards to the public. This ensures that each pool is in compliance with Chapter 26 of the Public Recreational Bathing Facility Rule.

Summer Youth Camp

Youth camps in the City of Englewood must register annually with the New Jersey Department of Health. The NJDOH sends a list of youth camps that require a pre-opening inspection to the Health Department. During the pre-opening inspection, the REHS reviews important items such as employee history checks, sex offender checks, CPR certifications, and health records. The REHS team ensures that the camp has a fully stocked binder with the policies and procedures of the camp, a first aid kit, a retail food license (if required) and a medical program. The youth camp must be in full compliance with Chapter 25 of New Jersey's Youth Camp Standards code in order to open for the season. In 2018, there were 4 youth camps in Englewood registered with the NJDOH.

Rabies Control

In October of 1989, the raccoon variation of rabies first came to Warren and Hunterdon Counties. Within three years, the fatal viral disease was detected in all 21 counties of New Jersey. To fight the spread of rabies, free rabies vaccination clinics are available through the Health Department, the Bergen County Animal Shelter and Twin Oaks Veterinary Hospital. At the Health Department's 2018 clinic alone, 78 cats and dogs were vaccinated against rabies.

Additional efforts to prevent the spread of rabies include investigation of all bite reports, requiring confinement of domestic pets involved in bites and quarantine of pets exposed to potentially rabid animals. The unit works with bite victims concerning rabies status of biting animals and the possibility of victims needing post exposure rabies prophylaxis. When necessary, the unit confers with State and County agencies to ensure the safety of the public.

Mentoring/Internships

Student internships are a key component in the work environment as these relationships provide an exploratory career experience. These experiences benefit the Health Department by providing a look at hiring potential, which adds more than just reviewing a resume. Students who serve as Environmental Interns enrich their career choices with real work experiences alongside the staff. Many students from Montclair State University, William Paterson University, and Rutgers University, majoring in Public Health, have pursued professional licenses to become a Registered Environmental Health Specialist after spending their internship hours at our health department.

PUBLIC HEALTH NURSING

Overview

The Public Health Nursing unit continues to provide comprehensive public health nursing services to the City of Englewood and surrounding areas. With preventive measures being the top, the department continued to promote its well-care services and support health education programs. The public reacted to favorably the programs overseen by the Public Health Nurse (PHN). Previously established programs were slightly modified to reflect a changing environment. New programs and practices implemented in 2018 have been evaluated in order to improve programming and effectively meet the community's needs.

The Public Health Nurse collaborates with other medical professionals in the community to enrich health services. Englewood Health Department's services include well-child clinics, adult vaccine clinics, blood pressure screening, community outreach, health referrals, lead education, A1C testing, school immunization audits, and patient education to reduce and stop the spread of infectious diseases. The Public Health Nurse also supports and facilitates questions from residents, school nurses, school administrators, and peers. The following practices have been established to suffice and enhance healthcare needs:

Child Health Conference (CHC)

The CHC is a wellness clinic that is focused on promoting the health of infants and school-aged children that are uninsured, American Indian, Alaskan Native, or have Medicaid Part A. It serves the Englewood community and surrounding areas and also provides physical examinations, health screenings, immunizations, health counseling, and other preventative health services to children ranging from newborn to 18 years old.

School Immunization Audits

From January to March, the Public Health Nurse performs an annual schools' immunization audit review. By mandate of the New Jersey Department of Health, student immunization is required in all public and private schools including daycares, nursery schools, preschools, kindergarten, elementary, and high schools per the CDC's recommended vaccine schedule. Children may be exempted from immunization for medical or religious reason. A physician licensed to practice medicine/osteopathic medicine or a nurse practitioner can provide medical exemptions, and they must indicate a set period of time in which the child cannot receive specific vaccinations. A religious exemption, based on the parents' religious beliefs, must be signed and dated.

Communicable Disease Reporting

Monitoring communicable and infectious diseases and educating the public is an ongoing process and are important components in reducing or eliminating the spread of disease. Infectious diseases spread through blood, body fluids, contact, droplets, food, and vectors. Many exotic diseases have made their way to the United States over the last few years, generating fear and anxiety. The Health Department continues to use education as a means to control the spread of diseases and create public awareness.

In 2018, Englewood had two confirmed cases of measles. The Public Health Nurse and Health Officer worked in collaboration with the State of New Jersey Department of Health to resolve the outbreak. The most prevalent communicable diseases recorded in the City are foodborne illnesses, hepatitis B, hepatitis C, and Lyme disease.

Adult Vaccine Preventable Disease Program

Adult Vaccine Preventable Disease is a program designed to maintain and minimize the spread of infectious diseases treatable through vaccines. The program provides vaccines at an affordable cost to uninsured adults in Englewood and surrounding communities. In addition, Mantoux skin test for tuberculosis and blood pressing screening are performed at the clinic. Most of the adult recipients of the affordable vaccines were non-resident aliens, who sought to change their status to resident alien.

Recertification of Vaccines for Children and Adult Vaccines Clinic

New Jersey State vaccine management and handling regulations play an integral part to the Department's every day functions. In order to remain compliant and eligible to administer vaccines, the Englewood Health Department clinic is recertified annually as required by the State of New Jersey vaccine program.

Education and Training

Remaining relevant and aware of procedures and changes in the public health environment is critical. As a result, the Public Health Nurse attended trainings, seminars, and webinars on a variety of topics including Vaccines for Children, Vaccine Preventable Disease, Communicable Disease Monitoring and Reporting, Immunization Audit, and Lead Training and Updates.

Community Outreach

The Public Health Nurse conducted numerous community outreach events, working in conjunction and collaboration with Englewood's schools, local churches and business, doctor's offices and various health fairs. Lectures on health topics were presented, health screenings for blood pressure, cholesterol, and blood glucose were performed.

The PHN also promoted NJWELL, a wellness program for employees focused on helping individual to set goals for optimal health. In addition, the PHN assisted participants with signing up and completion of the on-line health assessment.

The Department held its 4th six-week Diabetes Self Management Workshop at Dr. Suri's office from April 11th to May 16th. The program was successful and well received by residents.

In-service Training

The Public Health Nurse provided in-service training to Health Department staff on safe vaccine management and handling.

CLINIC STATISTICS

HEALTH EDUCATION & PROMOTION

The health educator is responsible for health education, promotion, and outreach activities. The goal is to reduce disease and prevent illness of people of all ages. This is accomplished by identifying community needs. Program planning and development takes place through evaluation, administration, communication and health promotion in different settings such as senior centers, health fairs, community events, places of worship and schools. The programs developed assist residents to adopt and support healthy behaviors.

NEW PROGRAMS

“No Excuses” Weight Loss Program

“No Excuses” Weight Loss Challenge was a 10-week program implemented at The Gym. “No Excuses” consisted of bi-weekly, one-hour group classes that included workout sessions, cooking classes, self-management strategies to overcome barriers, and a question and answer group. Participants had the opportunity to take part in biometric screenings which included blood pressure, hemoglobin A1C, and weigh-ins obtained at the Kickoff Event and Finale. The goal was for participants’ numbers to improve throughout the course of the program. The goal of “No Excuses” Weight Loss Challenge was to reduce the risk of heart disease among citizens through education and support by increasing access to physical fitness opportunities for Englewood residents. The program began with 20 participants and ended with 17. Throughout the 10 weeks, participants lost between 1 and 17 pounds.

Participants had regular weigh-ins, weekly motivational tips and advice via email, and support from the Health Educator. Throughout the program, participants received individual nutrition counseling and group nutrition classes from a Health and Nutrition Coach from The Gym in Englewood. The sessions focused on portion size, healthy substitutions, importance of drinking water and information to overcome barriers and individual issues of each participant. Participants also had the opportunity to attend two cooking classes at Le Gourmet Factory in Englewood, where participants helped throughout the cooking sessions, asked questions and learned about healthy food substitutions while making healthy recipes.

ACT NOW Foundation- Memory Screenings

The Health Department invited ACT Now Foundation to discuss dementia and present the different stages of the disease at the senior centers. Following the presentation, participants had the opportunity to take a diagnostic memory screening. The memory screening is a non-invasive question and answer assessment able to detect an early stage of dementia.

Walk Into Spring Wellness Challenge

Walk into Spring was an exciting 4-week program designed to connect the community with local business people while engaging in physical activity. The program featured leaders in the City of Englewood from various professions who give a brief presentation on their area of expertise. They then lead participants on the 1.5-mile walk. Participants had the opportunity to learn about a variety of issues, ask questions, and be entered for a chance to win one of five cash prizes. The

purpose of the program was to make new friends, get healthy and learn about health topics.

HEALTH PROMOTION

City of Englewood & Social Media Platforms

The Health Educator posts upcoming programs and monthly articles about important health topics on the Current Health News portion of the City of Englewood website. The article serves as a tool to educate the public on current health news and local events.

Facebook and Twitter posts are also made to include upcoming events, national health observances and current health topics.

Newsletter

An article is submitted quarterly the Englewood Health Watch newsletter on national health observances or upcoming programs and events. The article is printed and distributed for the community and on the city website.

REACH AND TEACH PROGRAM

The Youth Health Educator conducts several public health programs within the city. The position is partially funded by Englewood Health (formerly Englewood Hospital Medical Center). The program partners with local agencies and organizations in order to provide health education that challenges and encourages youth to make healthier choices. Initially outreach was set to be conducted in non-traditional settings such as the swimming pool, street fairs, school cafeterias, college fairs, parks, and agencies. In 2018, the Health Director and the Youth Health Educator conducted research, a community needs assessments, collaborated with teachers, school health personnel, and parents to address current health needs of youth in schools.

Ebenezer Summer Camp

Weekly gardening activities were conducted at the community garden with students from the Ebenezer Summer Camp. Students learned about a variety of vegetables and the importance of eating a balanced meal, where to get fresh vegetables and how to garden, along with other healthy behaviors. At the end of the program, students got a chance to taste the fresh vegetables from their garden.

Janis E. Dismus Middle School


A new health education curriculum was created for Janis E Dismus Middle School's 6th, 7th and 8th graders. It covers current health risk behaviors that youth are faced with and is in sync with health education standards for schools, incorporating the *Whole School, Whole Community, and Whole Child*. This is a collaborative approach to learning and health developed by the Association for Supervision and Curriculum Development (ASCD) and is supported by the CDC. The model is the current one for school health education, placing the child at the center, while requiring collaboration between health educators, teachers, parents, caregivers and the students, in order to fill in the gaps.

Students at Janis E. Dismus are learning how to choose healthy behaviors over risky behaviors. Some of the topics are Tobacco Products; Marijuana and Vaping – The Under Developed Brain; Online Violence; Underage Drinking; Puberty and Body Image; Nutrition and Health - Prevent | Promote | Protect.

Live Well Project

A nutrition plan was created for the Live-Well Program (Englewood Health) using a Power Point Presentation for high school classes. Students at Dwight Morrow High School learned the science behind nutrition and food, the importance of a nutritious, balanced diet, and how to read food labels and portion sizes.

Reach and Teach provided other youth health programs focused on serving Englewood youth, and their community.

MUNICIPAL ALLIANCE

The Program Coordinator/Assistant to the Director, the Health Educator and the Youth Health Educator promote the health and well-being of the residents of Englewood by their active involvement in the Municipal Alliance. In partnership with businesses, schools, non-profit organizations and faith based organizations, the Alliance works to promote public awareness, provide education and share resources. The goal is to encourage and support smart decision making about risky behaviors such as alcohol, tobacco and drug use.

The Department's Program Coordinator/Assistant to the Director is the Alliance Coordinator. In addition to coordinating each of eight the State-funded program activities, the staff has direct oversight of two of the programs – Sticker Shock and Stigma-Free. Funding received for these programs is reflected in the Department's Revenue.

Sticker Shock Campaign

The program is intended to educate owners of establishments that sell alcohol, and their customers, about the laws as they buy alcohol and the consequences of selling to or buying alcoholic beverages for anyone under the age of 21. The Youth Health Educator works with local high school students who place stickers and bottle hangers on alcoholic beverages in Englewood establishments with liquor licenses. The materials for the program are provided by The Center for Alcohol and Drug Resources.

Community Programs

The Stigma-Free Task Force held its annual Town Hall Meeting on May 4 at Englewood Hospital and Medical Center on the issue of mental health which focused on the Anxiety Solutions for Families. Expert diagnostician and cognitive behavioral therapist Dr. Anne Marie Albano was our special guest speaker for the evening. The event was co-sponsored by the Governor's Council on Alcohol and Drug Abuse, Englewood Hospital and Medical Center and the Health Department.

The Municipal Alliance also sponsored a NARCAN® training on February 22 at the Elks Lodge.

Community outreach regarding Safe Medicine Disposal methods was held at the Farmer's Market on June 29. In addition, the Alliance Coordinator promoted the two DEA National Prescription Drug Take Back days and the City's Project Medicine Drop (Rx drop box in the Police Department).

Stigma-Free Englewood hosted a table at the Seventh-day Adventist Church Health Fair on September 30, held at Teaneck Armory, and sponsored a Stress Management Workshop on October 15 in collaboration with the Health Department.

Mental Health First Aid Training (MHFA)

The Stigma-Free Task Force and the Health Department co-sponsored three Mental Health First Aid training sessions this year (January, July and December). The Department's certified instructor, along with all nationally certified instructors, attended training for the addition of a new opioid supplement. This was officially

added to the curriculum in October. In addition, the instructor successfully applied to NJ Learning Management Network, on behalf of Englewood Department of Health, to obtain public health leadership credits for Mental Health First Aid training, and a nominal fee was added to cover the cost of the training.
