BOARD OF HEALTH CITY OF ENGLEWOOD ORDINANCE NO. 08-02

AN ORDINANCE REVISING CHAPTER 6 OF THE HEALTH CODE OF THE CITY OF ENGLEWOOD, IN THE COUNTY OF BERGEN, NEW JERSEY, "FEES AND FEE SCHEDULE".

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF HEALTH OF THE CITY OF ENGLEWOOD, THAT THE FOLLOWING FEES AND FEE SCHEDULE BE REVISED;

SECTION 6.2 FEES FIXED

(d) Retail Food Service establishments:

(1) Food markets

Up to 3,000 sq. ft.	\$150.00
3,001 to 6,000 sq. ft.	\$200.00
6,001 to 10,000 sq. ft.	\$300.00
10,001 to 30,000 sq. ft.	\$500.00
30,001 to 50,000 sq. ft.	\$600.00
Over 50,001 sq. ft.	\$700.00

(2) Restaurants (per person seating capacity)

Less than 25	\$200.00
25 to 50	\$225.00
51 to 75	\$300.00
76 to 100	\$325.00
101 or more	\$350.00

(3) Vending machines:

Gum ball type	\$15.00 per machine
Coffee, tea, soup, etc.	\$35.00 per machine
Candy, gum, cookies, etc.	\$35.00 per machine
Soda, water, juice	\$35.00 per machine
Milk, ice cream, sandwich	\$35.00 per machine
(Potentially hazardous)	
Ice	\$35.00 per machine
Battery of five or more (same location)	\$100.00 per location

(4) Mobile food vendor	\$100.00
(5) Sweets, candies, gum	\$40.00
(6) Temporary Retail Food Establishment	\$35.00
(9) Farmer's Market (season)	\$40.00
(e) Swimming pools (non residential)	\$300.00

All other portions of Chapter 6, "Fees and Fee Schedule" shall remain unchanged.

This Ordinance shall take effect upon final passage and publication as required by law.
