

**ORDINANCE #24-12**

**ORDINANCE PROVIDING FOR VARIOUS  
IMPROVEMENTS OR PURPOSES TO BE UNDERTAKEN  
IN AND BY THE CITY OF ENGLEWOOD, IN THE COUNTY  
OF BERGEN, NEW JERSEY, AND REAPPROPRIATING  
\$584,610.50 THEREFOR, CONSTITUTING PROCEEDS OF  
A GRANT RECEIVED BY THE CITY FROM THE  
AMERICAN RESCUE PLAN ACT OF 2021.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
ENGLEWOOD, IN THE COUNTY OF BERGEN, NEW JERSEY, AS FOLLOWS:**

Section 1. The improvements described in Section 2 of this ordinance are hereby authorized to be made or acquired by the City of Englewood, New Jersey, as general improvements and there is hereby appropriated therefor the sum of \$584,610.50, said sum constituting proceeds from a grant received by the City from the American Rescue Plan Act of 2021 which grant funds were initially appropriated by a prior ordinance of the City for other purposes.

Section 2. The improvements hereby authorized and the several purposes for the financing of which the appropriation is made as provided in Section 1 of this ordinance are as follows: (a) the improvement of the sanitary and storm water drainage system of the City including the upgrade of culverts as needed in the City and the emergency replacement of drainage lines as needed in the City, (b) the installation of new LED marquee signage at various locations in the City and (c) the improvement of municipal buildings and facilities in and by the City including the upgrade of the first floor bathrooms in City Hall and the renovation of facilities associated with the relocation of the office of the City Clerk, together with for all the aforesaid all site work, landscaping, accessories, appurtenances, equipment, engineering, studies and design plans, work and materials, necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the City Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the City is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the City Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after final passage as provided by law.
