ORDINANCE #25-08

AN ORDINANCE AMENDING CHAPTER 191 (FEES), SECTION 12 (RECREATION DEPARTMENT), SECTION 14 (UNIFORM CONSTRUCTION CODES), CHAPTER 364 (SOLID WASTE AND RECYCLING), SECTION 11 (VIOLATIONS AND PENALTIES), AND CHAPTER 212 (FIRE PREVENTION), SECTION 17 (FIRE SAFETY PERMITS AND FEES) OF THE CODE OF THE CITY OF ENGLEWOOD

BE IT ORDAINED by the Council of the City of Englewood, Bergen County, New Jersey, as follows:

Section 1. Chapter 191, Section 12 (Recreation Department) is hereby amended to read as follows:

§ 191-12. Recreation Department Fees.

Additional Policies for Recreation Fees

- **B. (1) Discount Eligibility:** Englewood residents eligible for the reduced or free lunch program will qualify for a discount of 40% on football, track and field, tennis, basketball, and soccer program fees. Proper documentation of eligibility must be provided at registration.
- **B. (5) Camp Mackay Discount:** The Camp Mackay Day Camp discounted rate of \$150 \$160 per week per child is available for Englewood residents with multiple children who do not qualify for the reduced or free lunch program.
- **B. (8)(a) Processing Fee:** A \$10 processing fee will be applied to each transaction.
- **B. (2) Refund Policy:** A \$10 processing fee will be deducted from refunds unless the program is canceled.

Section 2. Chapter 191, Section 14 (Uniform Construction Codes) is hereby amended to read as follows:

§ 191-14. Uniform Construction Codes fees.

A. General.

- (2) Plan review. All fees required for plan review and the issuance of any permit or certificate shall be collected prior to the review or the issuance of the permit or certificate. Fees shall be computed in accordance with the requirements and standards set forth in the state uniform construction codes and in accordance with the following fee schedule, a copy of which shall be posted in the Central Permit Office. Plan review fee – 25% of the amount charged for a construction permit, minimum \$25 fee.
- (3) Off Hour Inspection/Standby Fee. Inspections conducted after regular business hours, weekends and/or holidays:

- (4) Administration Fee for processing fees for third party inspections \$100 per refund.

B. Building subcode fees

- (1) New construction permit fees shall be based upon the volume of the structure as computed in accordance with N.J.A.C. 5:23-4.18(c) promulgated under the Uniform Construction Code Act. The new construction permit fee shall be in the amount of \$0.06 (\$0.05) per cubic foot. The minimum fee for new construction shall be \$500.
- (2) Renovations and alterations.
- (a) Residential and commercial (cost per \$1,000 of total alteration costs):
- (1) Per \$1,000 up to \$100,000 of total alteration costs: (\$20) \$30
- (2) Per \$1,000 for \$100,000 to \$250,000 of total alteration costs: (\$15) \$25
- (3) Per \$1,000 over \$250,000 of total alteration costs: (\$10) \$15
- (4) Minimum fee: (\$60) (See above)
- (5) The fee for a permit for the moving of one building from one lot to another or to another location on the same lot shall be in the amount of (\$100) \$50 per \$1,000 of the estimated cost of moving plus the estimated cost of new foundations and all work necessary to place the building in its completed condition in the new location.
- (6)(b) All other signs requiring a permit pursuant to the uniform construction codes shall be as follows:

(7) The fees charged for a certificate of occupancy, certificate of continuing occupancy and certificate of zoning compliance shall be as follows:

- (a) The fee for a certificate of continuing occupancy shall be in accordance with the following schedule. In addition to the following fees, in the event a third inspection reveals previously noticed violations which remain unabated, an additional inspection fee equal to the fee for a certificate of continuing occupancy/rental occupancy shall be charged for such third inspection and each additional inspection performed until the violations are abated.

- (b) For each extension of the temporary certificate of occupancy, (\$30) \$45 will be charged.

(8) Uniform construction code variations

- (a) Residential Code variation: (\$100) \$500
- (b) Commercial Code variation: (\$300) \$500

(10) In addition to any other fee set forth herein, there shall be charged a State of New Jersey training fee in an amount of (\$0.00334) \$0.00371 per cubic foot of volume, which shall be charged to all new construction and additions to existing structures. Such fees shall be forwarded to the Bureau of Housing Inspection, Department of Community Affairs, pursuant to regulations adopted by the Commissioner of the Department of Community Affairs [(N.J.A.C. 5:23-4.19(b))]. The fee for all other construction shall be \$1.90 per \$1,000 of value of construction.

(11) Swimming pools.

(a) The fees for the construction and maintenance of swimming pools shall be as follows:

- (1) The fee shall be in the amount of (\$75) \$80 per first fixture and (\$30) \$35 per each additional fixture, except as limited in Subsection C(2) below. For the purpose of computing this fee, fixtures shall include lavatories, kitchen sinks, urinals, water closets, bathtubs, shower stalls, laundry tubs, floor drains, drinking fountains, dishwashers, garbage disposals, clothes washers, vent stacks or similar devices.
- (2) The fee shall be in the amount of (\$100) \$110 per special device for grease traps, oil sand, hair and plaster traps, sewer ejectors and sewer pumps. Stacks and Medical gas per outlet (\$30) \$40. VAV Boxes (\$50) \$60 each.
- (3) Required annual re-inspection (i.e. cross-connections backflow preventers) \$100
- (4) The fee for sanitary sewer connections or replacements: **NEW**
 - a. Residential: \$75 \$100
 - b. Commercial: \$150 \$160

Section 3. Chapter 364, Section 11 (Solid Waste and Recycling - Violations and Penalties) is hereby amended to read as follows:

§ 364-11. Violations and Penalties.

- A(1) For the first offense: a fine of \$25 \$125.
- A(2) For the second offense: a fine of not less than \$50 nor more than \$100 \$150.
- A(3) For the third offense: a fine of not less than \$100 \$150 nor more than \$200.
- A(4) For the fourth or more offense: a fine of not less than \$100 \$200 nor more than \$500.

Section 4. Chapter 212, Section 17 (Fire Safety Permits and Fees) is hereby amended to read as follows:

§ 212-17. Fire Safety Permits and Fees.

The fees for the following special inspections are hereby established.

- A. Special fire safety permits: issued according to N.J.A.C. 5:70-2.9(£). The application fee for a permit shall be as follows:
 - Type 1: From \$54 to \$108
 - Type 2: From \$214 to \$300
 - Type 3: From \$427 to \$600
 - Type 4: From \$641 to \$900

Section 5. Repealer

All ordinances or parts thereof inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 6. Severability

If any sentence, section, clause, or other portion of this ordinance or the application thereof to any person or circumstance shall for any reason be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or repeal the remainder of this ordinance.

Section 7. Fee Clarification

This ordinance amends and establishes new fees for the chapters, sections, and schedules outlined above. Fees not listed or addressed in this ordinance remain unaffected and are not repealed from the code.

Section 8. Effective Date

This ordinance shall take effect immediately upon passage and publication as required by law.
