### **ORDINANCE #25-09**

#### **AN ORDINANCE AMENDING CHAPTER 25, SECTION 25-18 SCHEDULE X AND SECTION 25-20, SCHEDULE XII OF THE TRAFFIC AND PARKING ORDINANCE OF THE CODE OF THE CITY OF ENGLEWOOD (TIETJEN AVENUE)**

**WHEREAS**, Chapter 25, Section 25-18 Schedule X restricts parking on certain streets within the City of Englewood; and

**WHEREAS**, Chapter 25, Section 25-20 Schedule XII prohibits parking during certain hours within the City of Englewood; and

**WHEREAS**, the Governing Body of the City of Englewood wishes to amend the aforesaid Sections to modify limitations on parking in designated areas on Tietjen Avenue.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Englewood, Bergen County, New Jersey, that Chapter 25-18, Schedule X is hereby amended to include as follows:

<b>Street</b>	<b>Side</b>	<b>Location</b>
Tietjen Ave.	South	From Lafayette Pl. to Decatur Ave., except on Fridays between 7 a.m. to 12:00 noon

**BE IT FURTHER ORDAINED** by the City Council of the City of Englewood, Bergen County, New Jersey, that Chapter 25-20, Schedule XII is hereby amended to include as follows:

Tietjen Ave.	North	7 a.m. to 12:00 noon	Friday	From Lafayette Pl. to Decatur Ave.

This Ordinance shall take effect immediately upon final passage and publication as required by law.
