ORDINANCE NO. 25-16**

**AN ORDINANCE OF THE CITY OF ENGLEWOOD ADDING SECTION 191-12 (D)  
REGULATING THE USE OF CITY OWNED TENNIS AND PICKLEBALL COURTS**

**WHEREAS**, there are publicly owned tennis and pickleball courts throughout the City of Englewood; and

**WHEREAS**, the City of Englewood wants to ensure their availability for use by residents of the City of Englewood; and

**WHEREAS**, the City of Englewood does not wish to permit said facilities to be used for for-profit or commercial purposes as it among other things restricts the availability for such facilities for Englewood residents.

**NOW, THEREFORE BE IT ORDAINED** that Chapter 191-12 of the City of Englewood Code is hereby amended as follows:

**D. REGULATING THE USE OF CITY OWNED TENNIS AND PICKLEBALL COURTS**

**(1.) Required for residents.**

No person residing within the City shall enter upon or use any tennis and/or pickleball court owned or operated by the City unless such resident shall then and there possess a resident tennis or pickleball pass issued in his/her name. The use of the City tennis and pickleball courts for revenue generating and/or commercial purposes, including but not limited to giving paid lessons is prohibited.

**(2.) Fee; term.**

**a. Fees.**

Single (14-59)	\$25.00
Family (Up to 2 adults and children under 14)	\$50.00
Senior citizen (60 and over)	\$ 5.00
Replacement ID Badge	\$10.00

**b. Fees.**

<b>Type of Non-Resident</b>	<b>Amount</b>
Single (14-59)	\$ 50.00
Family (Up to 2 adults and children under 14)	\$140.00
Senior citizen (60 and over)	\$ 25.00
Non-Affiliated Instructor	\$350.00
*Guest Fee (must be accompanied by a badge holder)	\$ 20.00
Team Fee	\$200.00 (per season)
Replacement ID Badge	\$10.00

**(3.) Terms.** Any resident may obtain a resident tennis or pickleball pass issued in his or her name from the Department of Recreation upon presentation of satisfactory proof of residence and payment of the appropriate fee as described in §\_\_\_\_\_. The resident tennis or pickleball pass shall be valid for one year from March 1 of the year issued. The age of the resident on the date of issuance of the tennis or pickleball pass shall determine the fee required. The resident tennis or pickleball pass may, upon expiration, be renewed for an additional period of one year upon application to the Department of Recreation and payment of the appropriate fee.

**(4.) Nonresident requirements.**

No person not residing within the City of Englewood shall enter upon or use any tennis or pickleball court owned or operated by the City unless:

- A. He/she shall be in the company of a City resident who has a current tennis or pickleball pass and a current guest pass.
- B. He/she shall present or surrender a nonresident tennis or pickleball pass to such City employee who shall be then and there supervising said tennis or pickleball courts.

**(5.) Nonresidential tennis or pickleball pass.**

A nonresident tennis or pickleball pass may be obtained only by a resident of the City upon the payment of a fee of as outlined in B. Fees for Non-Residents, regardless of the age of the nonresident, to the Department of Recreation. A resident may obtain any number of such nonresident tennis or pickleball passes from the Department of Recreation upon payment of the fifteen-dollar fee for each pass. Each nonresident pass shall be valid for the period of March 1 through December 31<sup>st</sup> annually of use of a City tennis or pickleball court and shall be surrendered as provided by § \_\_\_\_\_.

**(6.) Definitions.**

As used in this article, the following terms shall have the meanings indicated:

**RESIDENT**

A record owner of property or taxpayer.

**(7.) Violations and penalties.**

Any person who violates any provision of this article shall, upon conviction, be subject to a fine not to exceed \$200.00.
