

**CITY OF ENGLEWOOD**

**ORDINANCE NO. 25-19**

**AN ORDINANCE AUTHORIZING THE EXECUTION OF A LEASE BETWEEN THE  
CITY OF ENGLEWOOD AND THE BERGEN FAMILY CENTER**

**WHEREAS**, the City of Englewood is the owner of property located at Lot 26, Block 2304 on the Tax Map of the City of Englewood, more commonly known as 37 Amory Street; and

**WHEREAS**, the Bergen Family Center a New Jersey tax exempt and non-profit corporation, having offices at 44 Armory Street, Englewood, NJ, has requested that the City of Englewood agree to enter into a Lease agreement which would provide for the Lease of the property located at Lot 26, Block 2304 ("Premises")

**WHEREAS**, the Bergen Family Center intends to manage and operate the Premises so as to provide parking relief for the organization and the residents that live on the street; and by providing off-street parking to the organization during day time hours and allowing residents to park in the lot during evening and overnight hours, street parking will have more availability for the organization and City residents alike; and

**WHEREAS**, the Local Lands and Buildings Law authorizes a governing body to lease municipally-owned land to a non-profit corporation for a public purpose (N.J.S.A. 40A:12- 14(c)), for a maximum Lease term of 75 years (N.J.S.A. 40A:12-15) and to convey municipal property to a duly incorporated non-profit organization or association in compliance therewith (N.J.S.A. 40A:12-21); and

**WHEREAS**, the Governing Body of the City of Englewood has determined that it is in the public interest to enter into the Lease Agreement, as permitted by the Local Lands and Buildings Law, in a form approved by the City Attorney and attached hereto as Exhibit A.

**NOW, THEREFORE, BE IT ORDAINED**, as follows:

**Section 1.**

A Lease between the City of Englewood, as Landlord, and the Bergen Family Center, as Tenant, of the Premises located at Lot 26, Block 2304, more commonly known as 37 Amory Street, according to the terms set forth in Exhibit A herein, is hereby approved, and the City Manager and City Clerk are hereby authorized and directed to execute and deliver the Lease Agreement on behalf of the City of Englewood.

**Section 2.**

Annual rent shall be for \$1.00.

**Section 3.**

The public purpose of the Lease Agreement is to manage and operate the Premises so as to provide parking relief for the organization and the residents that live on the street; and by providing off-street parking to the organization during day time hours and allowing residents to park in the lot during evening and overnight hours, street parking will have more availability for the organization and City residents alike.

**Section 4.**

The term of the Lease Agreement shall be for two (2) years with a renewal option for one (1) one-year term.

**Section 5.**

The law requires that the Bergen Family Center annually submit a report to the City of Englewood's City Manager which report shall set forth the uses of the Premises that were undertaken by the Bergen Family Center during the prior year, the activities that the Bergen Family Center has undertaken in furtherance of the public purpose for which the leasehold was granted, and an affirmation of the continued tax-exempt status of the Bergen Family Center as a nonprofit corporation pursuant to both State and Federal law.

**Section 6.**

This Ordinance shall take effect after final passage and publication in accordance with law.
