

**CITY OF ENGLEWOOD**

**Ordinance No. 20-05**

**AN ORDINANCE AMENDING CITY CODE CHAPTER 254, ARTICLE II, SECTION 15**  
**PERTAINING TO HOURS OF OPERATIONS FOR LAUNDRIES AND**  
**LAUNDERETTES**

**WHEREAS**, Chapter 254, Article II, Section 15 of the City Code restricts the hours a laundry or launderette may operate; and

**WHEREAS**, the Governing Body of the City of Englewood wishes to amend the City Code as it has determined that such services are a necessary and vital part of people's health and hygiene; and

**WHEREAS**, restricting such services from being open on Sunday prohibits reasonable access to such necessary services.

**NOW, THEREFORE, BE IT ORDAINED**, that Chapter 254, Article II, Section 15 of the City Code shall be amended as follows:

**§ 254-15 Hours of operation.**

No laundry or launderette shall begin operations before 6:00 a.m. or continue to operate after 11:00 p.m.

This Ordinance shall take effect immediately upon passage and publication as required by law.


