**ORDINANCE NO. 20-09**

**AN ORDINANCE AMENDING 56-1 PERTAINING TO  
POST RETIREMENT BENEFITS FOR THE POSITIONS OF  
THE CHIEF AND DEPUTY CHIEF OF  
THE CITY OF ENGLEWOOD POLICE DEPARTMENT**

**WHEREAS**, the City of Englewood seeks to codify post-retirement benefit sick leave benefits for the positions of the City of Englewood Police Chief and Deputy Police Chief; and

**WHEREAS**, said post-retirement benefits are applicable only for the time period within which an individual served as the Deputy Police Chief and Police Chief, and does not alter such post-retirement benefits accrued while serving as a patrolman through captain as set forth in the applicable Collective Bargaining Agreement which provides for payment of up to 150 days for rank and file Police Officers;

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the City of Englewood for the positions of City of Englewood Police Chief and Deputy Police Chief, appointed after the effective date of this Ordinance, the following post-retirement sick leave benefit shall apply:

1. For the period of time in which an Officer serves as a Patrol Officer through Captain, the eligible sick leave time shall be not more than 150 days as set forth in the Collective Bargaining Agreement as of this date.
2. For the time period in which an Officer serves as the City of Englewood Police Chief or Deputy Chief of Police, there shall be no additional accrued sick time benefits, and the amount of eligible sick time shall be capped at 150 unused days, and paid at the Officer's highest rate of compensation as a rank and file Police Officer.

This Ordinance shall take effect in accordance with all applicable laws.
