ORDINANCE NO. 22-12

**ORDINANCE CANCELING \$2,966,506 IN UNFUNDDED
BALANCES FROM VARIOUS BOND ORDINANCES
PREVIOUSLY ADOPTED BY THE CITY OF ENGLEWOOD, IN
THE COUNTY OF BERGEN, STATE OF NEW JERSEY**

WHEREAS, the various bond ordinances listed on Exhibit A attached hereto and by this reference made a part hereof (the "Prior Ordinances") were each duly adopted by the City Council of the City of Englewood, in the County of Bergen, State of New Jersey (the "City"); and

WHEREAS, certain capital equipment, projects and improvements (the "Prior Projects"), which were described, appropriated and authorized under the Prior Ordinances, have been completed, abandoned or are no longer needed for their intended purposes; and

WHEREAS, the City Council now desires to cancel the remaining unfunded balances in the Prior Ordinances totaling \$2,966,506, as detailed in Exhibit A attached hereto, which were previously appropriated and authorized in the Prior Ordinances for such Prior Projects but no longer needed for their intended purposes.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
ENGLEWOOD, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY (not less than
two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:**

SECTION 1. The foregoing recitals are incorporated herein as if set forth in full.

SECTION 2. The Prior Projects described, appropriated and authorized under the Prior Ordinances have been completed, abandoned or are no longer needed for their intended purposes and the remaining unfunded balances in such Prior Ordinances totaling \$2,966,506, as detailed in Exhibit A attached hereto, are hereby cancelled as of the date of this ordinance.

SECTION 3. This ordinance shall take effect twenty (20) days after the first publication hereof after final adoption and approval by the Mayor, as provided by the Local Bond Law.
