**ORDINANCE NO. 22-22**

**AN ORDINANCE AMENDING §61-2(A.) PERTAINING TO  
COMPOSITION OF THE TABLE OF ORGANIZATION FOR  
THE CITY OF ENGLEWOOD POLICE DEPARTMENT**

**WHEREAS**, the City of Englewood seeks to amend the Table of Organization for the Police Department to increase the number of positions for Lieutenant, Sergeant and Police Officers from not more than two, to not more than three; and

**WHEREAS**, said increase will provide increased supervisory and managerial over-sight for the City of Englewood Police Department thereby increase the health, safety and public welfare for the residents of the City of Englewood;

**NOW, THEREFORE, BE IT ORDAINED** by the Governing Body of the City of Englewood for that the Table of Organization, as codified in §61-2 (A.) shall be amended as follows:

The Police Department Table of Organization shall consist of one Chief of Police and may consist of not more than one Deputy Chief of Police, not more than three Captains, not more than ~~(five)~~ six Lieutenants, not more than ~~(twelve)~~ fourteen Sergeants and not more than ~~(64)~~ 65 police officers.

This Ordinance shall take effect in accordance with all applicable laws.
