ORDINANCE #25-42

AN ORDINANCE AMENDING CHAPTER 191 ENTITLED FEE SCHEDULE OF THE CODE OF THE CITY OF ENGLEWOOD (RECREATION ACTIVITIES)

WHEREAS, Chapter 191 of the Code of the City of Englewood sets for the fee schedule for a variety of activities throughout the City of Englewood, including recreation activities; and

WHEREAS, the Governing Body of the City of Englewood seek to amend said schedule as it pertains to the use of Tennis and Pickleball facilities by residents of the City of Englewood and waive said fees for residents of the City of Englewood.

NOW THEREFORE BE IT ORDAINED by the Governing Body of the City of Englewood that Chapter 191 of the City Code is hereby amended as follows:

Chapter 1 91-12 Entitled “Recreational Facilities/Programs” is hereby amended to provide that no fees shall be charged to Englewood residents for use of Tennis and Pickleball facilities owned by the City of Englewood.

BE IT FURTHER ORDAINED by the Governing Body of the City of Englewood that fees pertaining to the use of the McKay Ice Rink as set forth in Chapter 191-12 are hereby amended as follows:

**The rink rental rate for non-residents shall be \$560 per hour;
The rink rental rate for residents shall remain fixed at the current rate of \$440 per hour;**

**The fees for the LTS Program shall be increased from \$150-\$225 for non-residents;
The fees for the LTS program for residents shall be increased from \$100-\$150.**

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies. All other Ordinances or parts of Ordinances shall otherwise remain in full force and effect.

If any Article, Sections, Subsection, paragraph, phrase or sentence is for any reason held to be unconstitutional or invalid said Article, Section, Subsection, paragraph, phrase or sentence shall be deemed severable.

This Ordinance shall take effect immediately upon final publication as provided by law. In order to coincide with the 2026 ice rink season the amended fees shall take effect October 1, 2026.
