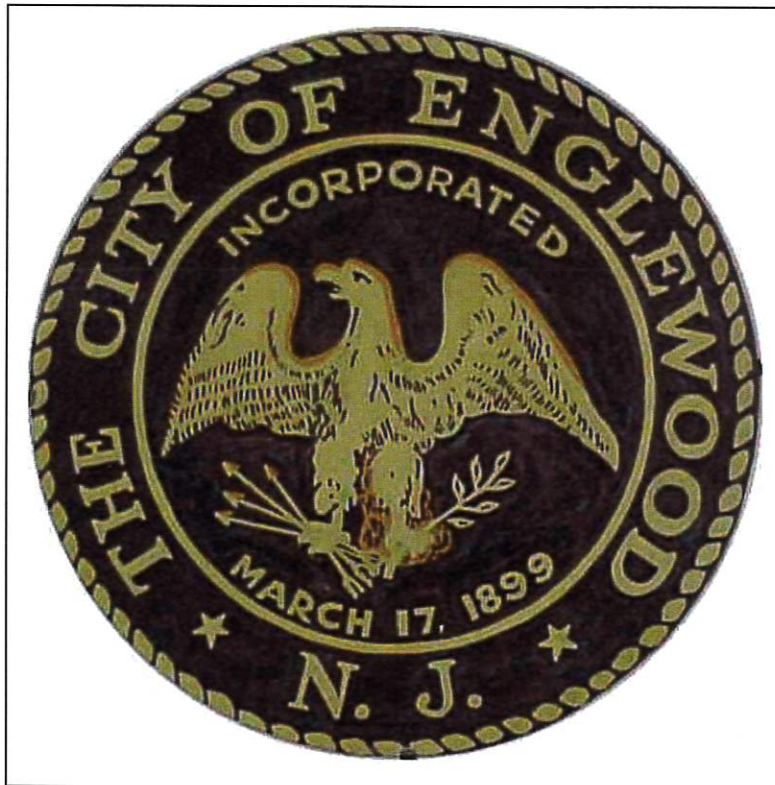

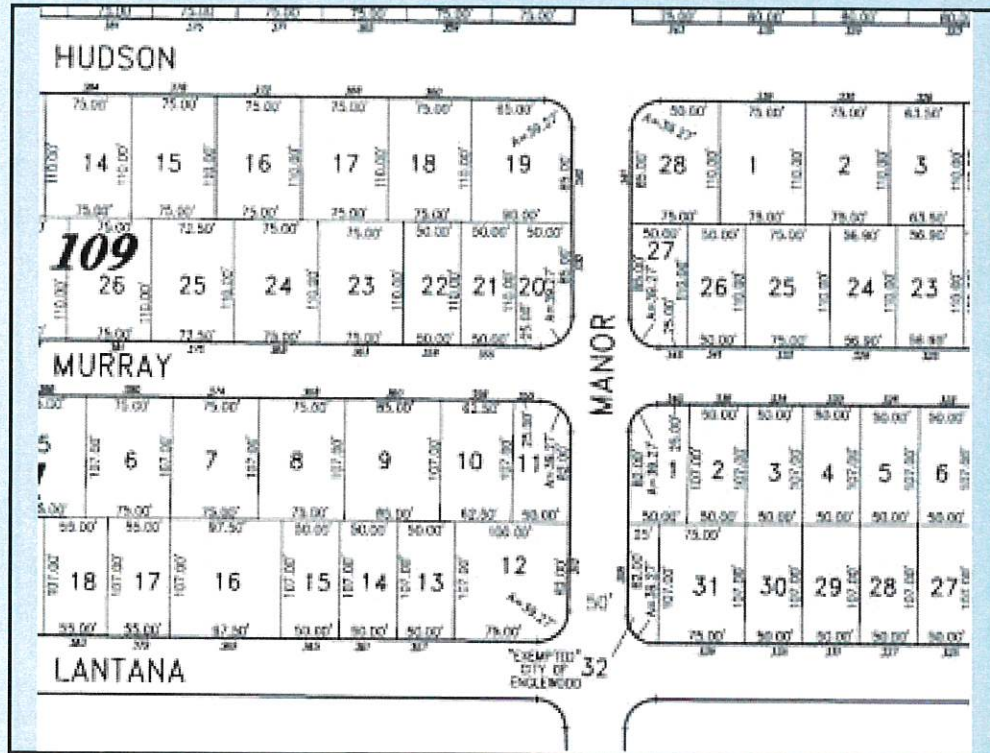

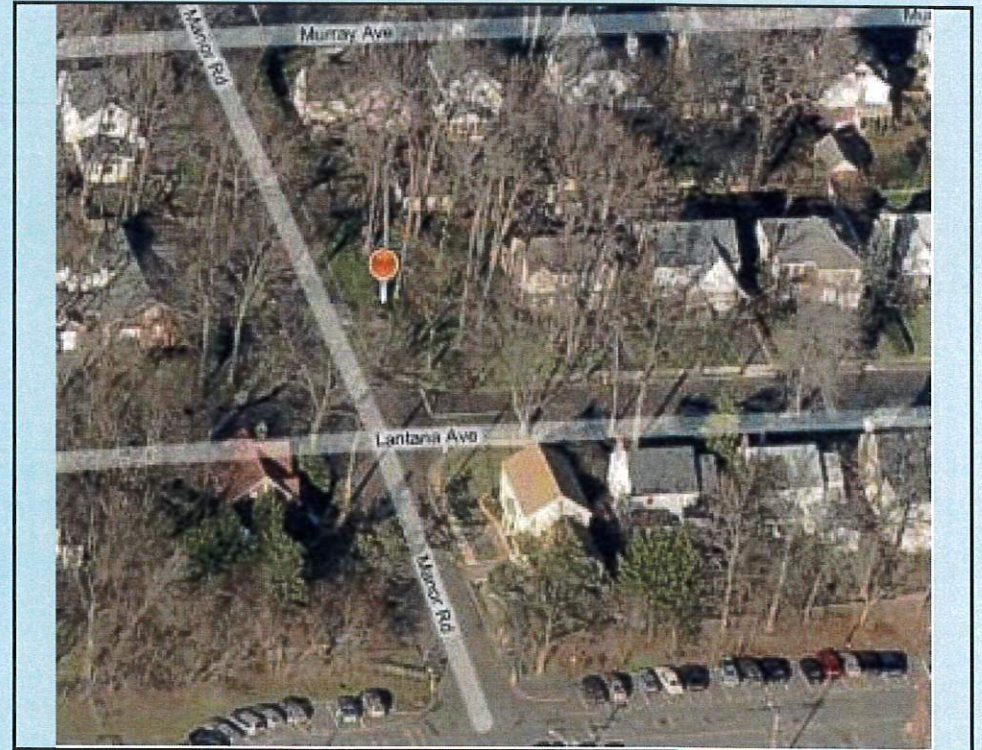
Block	Lot	Address	Description	Recommendations	Sell/ Hold
112	32	309 Manor Road	Vacant Lot. Borders Residential property. This narrow strip of property is too small to be a buildable lot. It is vacant. The adjacent property to the east is a single family residence.	Deed to adjoining property owner to provide a larger lot. By combining with Lot 31, it may be possible to have two building lots, each 50 ft. wide (subject to Planning Board approval).	Sell

**Zone District:** R-D Single Family

**Property Size:** Approximately 25 ft. wide by 100 ft. deep.

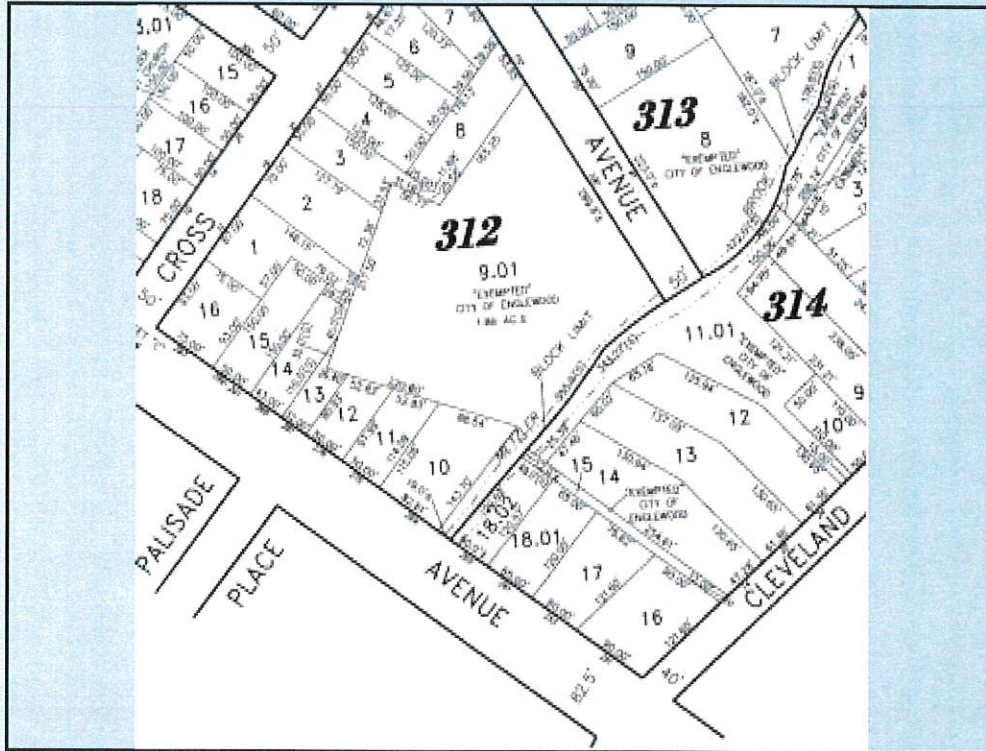

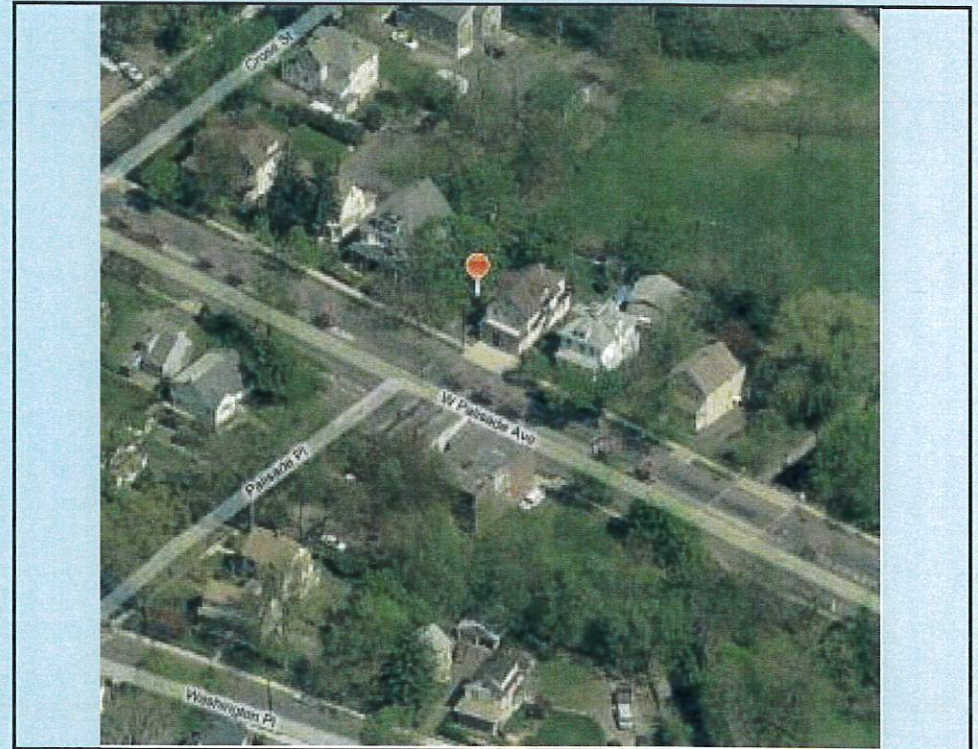
Block	Lot	Address	Description	Recommendations	Sell/ Hold
312	13	281 W. Palisade Ave	Vacant Lot. Undersized residential lot. It can be attached to one or both lots that are adjacent to it on the east or west side of the subject lot. It is not of sufficient size to be a buildable lot.	Sell to either or both property owners with adjacent undersized lots to form a more conforming lot(s).	Sell

**Zone District:** R-E Single Family

**Property Size:** Approximately 32 ft. wide by 81 ft. deep.

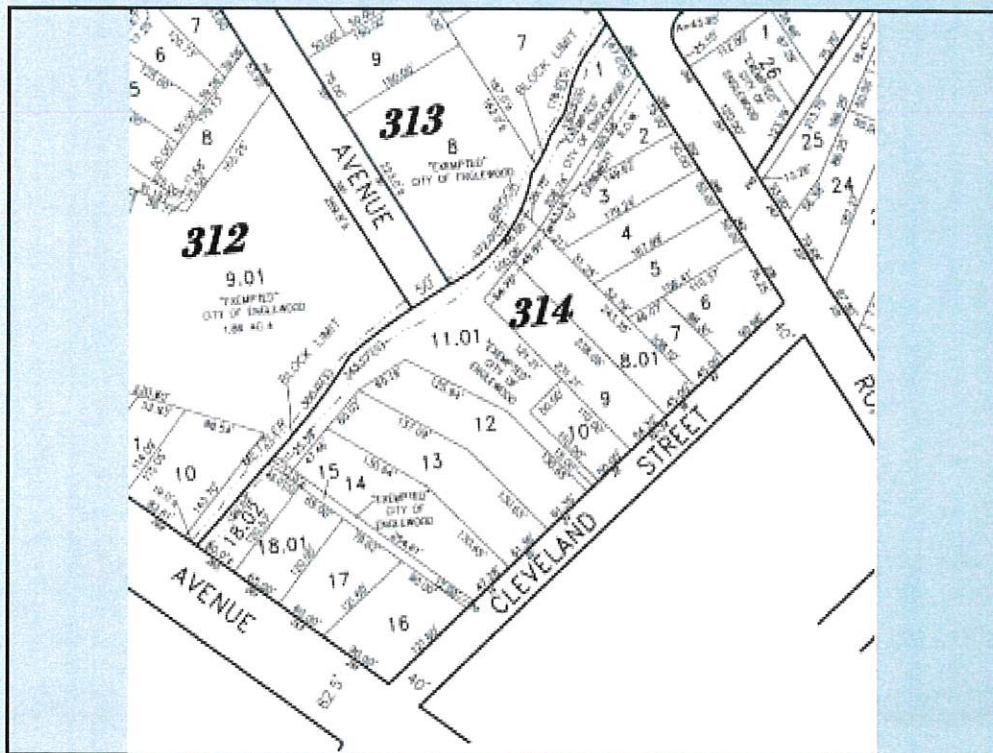

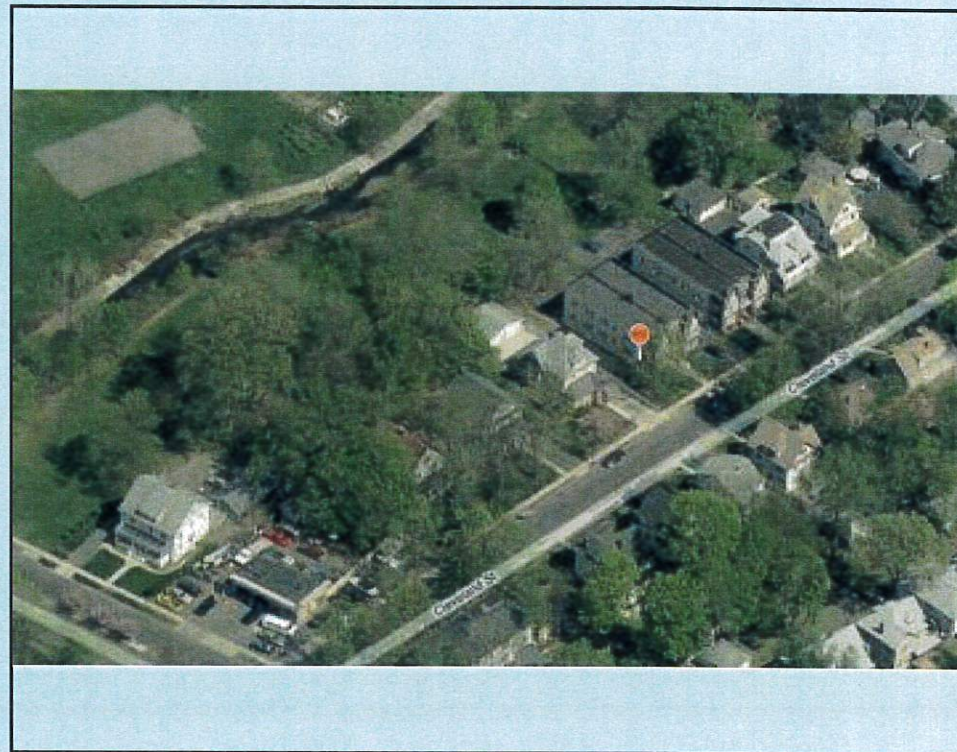
Block	Lot	Address	Description	Recommendations	Sell/ Hold
314	11.01	26 Cleveland St	Vacnt Lot. This property provides access to Metzlers Brook from Cleveland Street. It has a 15 ft. wide strip from Cleveland Street and opens up along the Brook with a large section of land behind Lot 10.	Retain access from W. Palisade and retain at least 15 ft. along the Brook but dispose of the area behind Lot 10. Lot 10 is a 4 family building and the additional land will improve Lot 10.	Sell

**Zone District:** R-E Single Family

**Property Size:** Irregularly shaped, slightly in excess of 0.5 acres.

Block	Lot	Address	Description	Recommendations	Sell/ Hold
2002	3	266 W. Palisade Ave	Vacant land bordering and including Metzlers Brook. The land provides access to the open channel.	There is sufficient land for a subdivision retaining access to the Brook. Subdivided portions of the lot could be sold to adjacent property owners to form larger more conforming lots.	Sell

Zone District: R-E Single Family

Property Size: Less than 1 acre in total including the Brook.
