ORDINANCE #25-43

AN ORDINANCE AMENDING CHAPTER 25-18 OF THE CITY OF ENGLEWOOD CODE REGARDING PARKING ON LAFAYETTE PLACE, ENGLEWOOD, NEW JERSEY

WHEREAS, Chapter 25-18 of the City of Englewood Code and Schedule X which is incorporated therein addresses no parking on various streets within the City of Englewood; and

WHEREAS, the Governing Body of the City of Englewood wishes to amend the no parking regulations as they pertain to Lafayette Place.

NOW THEREFORE, BE IT ORDAINED that Chapter 25-18, Schedule X is hereby amended as follows:

<u>Street</u>	<u>Side</u>	<u>Location</u>
Lafayette Place	East	No parking from 10:00 p.m. to 6:00 a.m. on the east side of the street from the Teaneck border to West Forest Avenue.
		No parking on the east side of the street from Rosemont Place to West Forest Avenue at all times.

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies. All other Ordinances or parts of Ordinances shall otherwise remain in full force and effect.

If any Article, Sections, Subsection, paragraph, phrase or sentence is for any reason held to be unconstitutional or invalid said Article, Section, Subsection, paragraph, phrase or sentence shall be deemed severable.

This Ordinance shall take effect immediately upon final publication as provided by law.
