**PLEASE TAKE NOTICE** that in accordance with the provisions of the Senator Byron M. Baer Open Public Meetings Act, N.J.S.A. 10:4-6, et seq. and, particularly, N.J.S.A. 10:4-8, which defines a “Meeting” as “any gathering whether corporeal or by means of communication equipment”, the Planning Board of the City of Englewood will hold a Re-Organization Meeting and Regular Meeting on **Thursday, January 22, 2026 at 7:30 PM** by remote video/audio conference.

There will be no in-person meeting. The meeting would otherwise have taken place in the Council Chambers at the Englewood Public Safety Complex, 73 S. Van Brunt St., Englewood, New Jersey 07631.

The remote meeting may include the adoption of minutes and resolutions, completeness reviews and the granting of related waivers, and public hearings on applications for development and such other matters as may come before the Board, including a closed session. Formal action may be taken.
